AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF LAW OFFICES OF ALAN E. WEINSTEIN, LLC, A FLORIDA LIMITED LIABILITY COMPANY

In accordance with Sections 605.0202 and 621.13 of the Florida Statutes, the Articles of Organization of Law Offices of Alan E. Weinstein, LLC, a Florida limited liability company, originally filed with the Florida Department of State on January 2, 2008 and assigned Florida Document Number L08000000280, are hereby amended and restated as follows:

This Professional Limited Liability Company (the "Company") is organized under the provisions of Chapters 605 and 621 of the Florida Statutes for the purpose of providing the professional services hereafter specified:

ARTICLE I. NAME.
