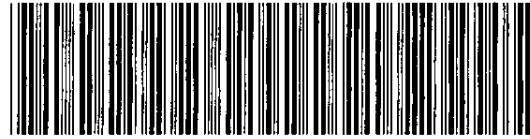

The name of the Limited Liability Company is CORAL WAY CENTER, LLC (the "Company").


ARTICLE II - Address


