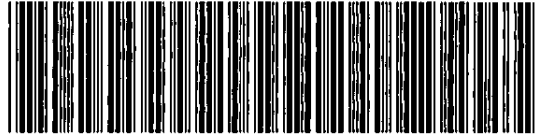

ARTICLES OF ORGANIZATION IN LIEU OF MEETING**

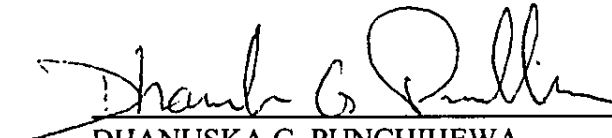
