ARTICLES OF ORGANIZATION  
OF  
DOUGLAS CARLAN, M.D., P.L.

The undersigned, acting as the organizer of a professional limited liability company to be formed under the Florida Professional Service Corporation and Limited Liability Company Act, as amended (the "Act"), hereby forms a Florida professional limited liability company (the "Company") pursuant to the Act and hereby sets forth the following Articles of Organization (the "Articles"):

ARTICLE I

Name

The name of this Company shall be "Douglas Carlan, M.D., P.L.".

ARTICLE II

Business and Purpose

The business of the Company shall be limited to, and the sole and specific purpose for which the Company is organized is, rendering professional services in all phases and aspects of the practice of medicine in the State of Florida; provided, however, the Company may also invest its funds in real estate, mortgages, stocks, bonds or any other type of investments, and may also own and lease real and personal property necessary for the rendering of its professional medical services.

Management of Business

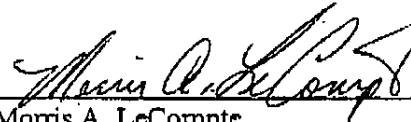

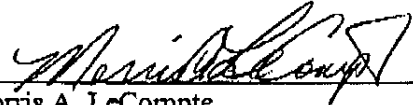
