ARTICLES OF ORGANIZATION OF CENTRAL FLORIDA INSURANCE AND INVESTMENTS GROUP, LLC.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE 3 - NAME

The name of the limited liability company shall be CENTRAL FLORIDA INSURANCE AND INVESTMENTS GROUP, LLC.

ARTICLE VI - ADMISSION OF NEW MEMBERS
