**ARTICLES OF ORGANIZATION  
OF

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I. NAME**

The name of this limited liability company is **FLORIDA PEDIATRIC EAR, NOSE, AND THROAT ASSOCIATES, P.L.** (the "Company"), and it shall be formed as a professional limited liability company under Chapter 621 and Chapter 608 of the laws of the State of Florida.

**ARTICLE II. ADDRESS**

**ARTICLE III. DURATION**
