**ARTICLES OF AMENDMENT
TO THE ARTICLES OF ORGANIZATION
OF
FLORIDA PEDIATRIC EAR, NOSE, AND THROAT ASSOCIATES, P.L.**

Pursuant to Section 608.411 of the Florida Statutes, **FLORIDA PEDIATRIC EAR, NOSE, AND THROAT ASSOCIATES, P.L.**, a Florida professional limited liability company, hereby adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is **FLORIDA PEDIATRIC EAR, NOSE, AND THROAT ASSOCIATES, P.L.**
2. The limited liability company was organized on January 3, 2008 by the filing of Articles of Organization with the Florida Secretary of State.
3. Article I of the limited liability company's Articles of Organization is hereby amended in its entirety to read as follows:

ARTICLE I. NAME

The name of the limited liability company is **CENTA, P.L.** (the "Company"), and it shall be formed as a professional limited liability company under Chapter 621 and Chapter 608 of the laws of the State of Florida.
