# ARTICLES OF ORGANIZATION

The undersigned initial members of KRAMERMAN ENTERPRISES, LLZ, a Florida limited liability company formed hereunder (the "Company"), hereby form a limited liability company under the laws of the State of Florida.

#### ARTICLE I. COMPANY NAME
