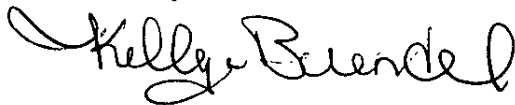

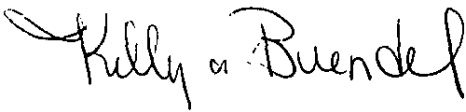

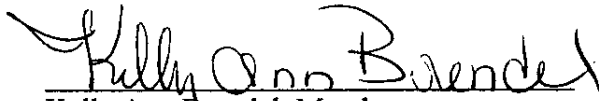
ARTICLE VIII

ARTICLE IX

Regulations adopted by the members may be repealed or altered, new regulations may be adopted, and the members may prescribe in any regulation made by them that such regulations may not be altered, amended or repealed by any manager. The regulations shall govern and address items relating to the day to day operation of the company's business and shall address, without limiting the generality of the foregoing, such items as return of capital and distribution of profits and losses as between members.

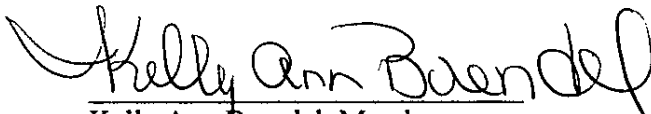
