**ARTICLES OF ORGANIZATION
OF
CKC BOLDT, LLC**

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

**ARTICLE I
NAME**

The name of this limited liability company is CKC BOLDT, LLC, ("Company").
