**ARTICLES OF ORGANIZATION  
OF  
THE ORCHID INVESTMENTS, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as the same may from time to time be amended (the "Act").

**ARTICLE I - NAME**

The name of this limited liability company (the "Company") is The Orchid Investments, LLC.

**ARTICLE II - ADDRESS**

The address of the principal office and mailing address of the Company is 1031 First Street South, #1405, Jacksonville Beach, Florida 32250.

**ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT**


