The name of this Limited Liability Company shall be BLYSKAL ADVERTISING WORKS, LLC (the "Company").


ARTICLE II

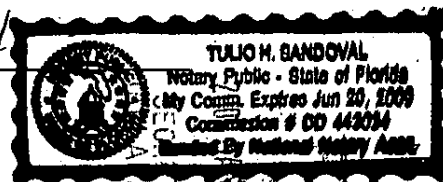
