The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

## ARTICLE I -- NAME

The name of the limited liability company shall be Negawatt Services LLC (the "Company").

## ARTICLE II -- ADDRESS


## ARTICLE IV -- REGISTERED OFFICE AND AGENT

The Company shall be a manager-managed company, as that term is used in Section 608.422(3), Florida Statutes, and in accordance with the terms of the Operating Agreement adopted by the Company's members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles.

IN WITNESS WHEREOF, the undersigned organizer has made and subscribed these Articles of Organization at Naples, Florida, on this 9th day of January, 2008.


