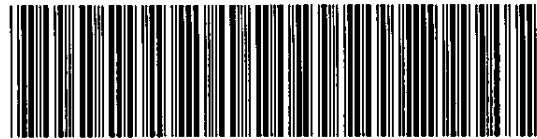

ARTICLE I

Name and Duration

The name of this Limited Liability Company is JOHNSTON INTERNATIONAL GROUP LLC (hereinafter referred to as the "Company"). The duration of the Company shall be perpetual.

ARTICLE II

Principal Office

The address of the principal office of the Company is 135 E. Colonial Drive, Orlando, FL 32801, or such other place as the Member may determine from time to time. The mailing address shall be the same as the principal office address.

ARTICLE III

Registered Office and Agent

ARTICLE IV

Company Purposes, Powers and Rights
