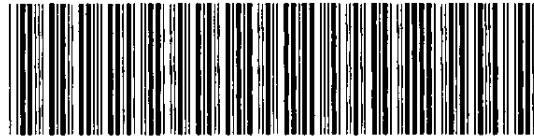

ARTICLE III - DURATION


