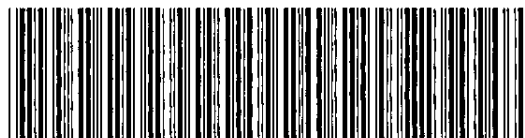

ARTICLE I
NAME

The name of the limited liability company to be formed hereunder is "LOUIS PAPPAS MARKET CAFÉ – BLOOMINGDALE, LLC" (the "Company").

MANAGEMENT






