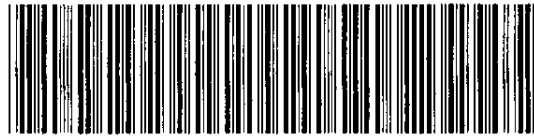



ARTICLES OF ORGANIZATION

This limited liability company shall have perpetual existence, unless sooner voluntarily dissolved according to law.



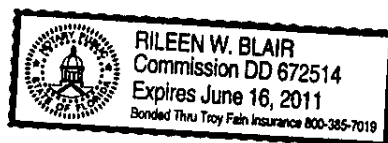


