- C. Article I of the Articles of Organization is hereby amended and restated in its entirety to read as follows:

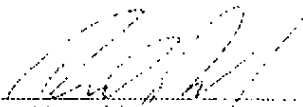

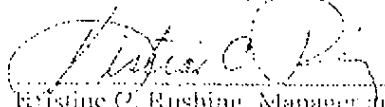
The name of the Limited Liability Company is ASCEND INVESTMENT PARTNERS, LLC."
