the remaining members; provided that at least two members remain.

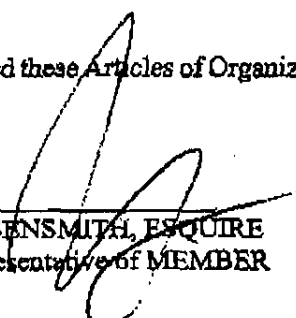
ARTICLE IX - AMENDMENT
