

ARTICLES OF ORGANIZATION OF MONKEYTEX, LLC

f organizing a Florida Limited

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 698).

Article 1 - Name

The name of this limited liability company is MonkeyTeX, LLC ("Company").
