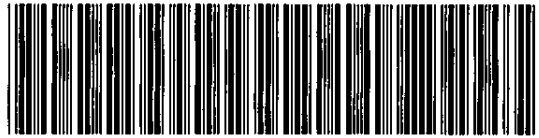

The name of the Limited Liability Company is SAFETY HARBOR MOTEL, LLC.


