



The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act") for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

1. Name.

The name of the limited liability company is James E. Smith Fernery, LLC, (hereafter referred to as the "Company").

2. Address of the Place of Business.
