ARTICLE I - NAME

The name of the Limited Liability Company is **FOR RENT BY ME, LLC**

ARTICLE II - ADDRESS

The mailing address and the street address of the principal office of the Limited Liability Company is **2494 SUNDOWN LANE, LANTANA, FL 33462.**

ARTICLE III - MEMBERS

ARTICLE VIII - POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of the members of the company. 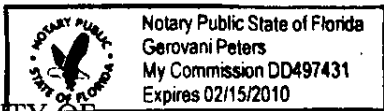

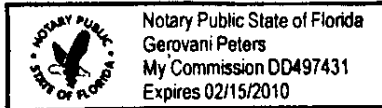
