

ARTICLE I -NAME

The name of the Limited Liability Company is FOR RENT BY ME, LLC

ARTICLE II - ADDRESS

The mailing address and the street address of the principal office of the Limited Liability Company is 2494 SUNDOWN LANE, LANTANA, FL 33462.

ARTICLE III - MEMBERS


