**ARTICLES OF ORGANIZATION
OF
SCHOPKE & ASSOCIATES, LLC
A Florida Limited Liability Company**

The undersigned, for the purpose of forming a Limited Liability Company under F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company shall be SCHOPKE & ASSOCIATES, LLC, sometimes hereinafter referred to as "Company."

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company is 1620 Tangerine Street, Melbourne, Florida 32901.

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is dissolved earlier as provided in these Articles of Organization or by Florida law.

ARTICLE IV - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is NEIL SCHOPKE, 1620 Tangerine Street, Melbourne, FL 32901.

ARTICLE V - PURPOSE

The purpose of this Company is to engage in design, engineering, construction and consultation, through its member who is licensed by the State of Florida. In addition, the Company may transact any and all lawful business for which limited liability companies may be organized in the State of Florida.

ARTICLE VI – INITIAL CAPITAL CONTRIBUTIONS

This company initially commences business as a single-member limited liability company. The initial member shall make an initial capital contribution as set forth in the Operating Agreement. Contributions may be made in cash or “in kind.”

ARTICLE VII – ADDITIONAL CAPITAL CONTRIBUTIONS

Members shall make capital contributions to the Company only on the unanimous consent of all the members, or as provided in the Operating Agreement.

ARTICLE VIII – ADMISSION OF NEW MEMBERS

Except as may be set forth in the Operating Agreement, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all members. A member may transfer his or her interest in the Company as set forth by Florida law or in the Operating Agreement of the Company.

ARTICLE IX – MEMBERS’ RIGHT TO CONTINUE BUSINESS

The Company shall not dissolve on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the membership of a member in the Company, unless the Company is dissolved by the unanimous vote of all the remaining members or their legal representatives.

ARTICLE X – MANAGEMENT

The Company shall be managed in accordance with the Operating Agreement adopted for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with Florida law or these Articles of Organization.


ARTICLE XII - POWERS

ARTICLE XIII - PROFITS AND LOSSES


