**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
FOR****SMTM 1100 WEST LLC**
A Florida Limited Liability Company

Pursuant to the provisions of Section 608.411 of Florida Statutes, this Florida Limited Liability Company, originally named SMTM Florida Properties LLC and currently named SMTM 1100 West LLC, deletes, in its entirety, all of provisions of the Articles of Organization which were originally filed on January 18, 2008, with the Florida Department of State, Division of Corporations, and adopts the following as its Articles of Organization, which is a complete restatement thereof:

ARTICLE I
NAME

The name of the limited liability company (the "Company") is changed from SMTM Florida Properties LLC to SMTM 1100 WEST LLC.

ARTICLE II
