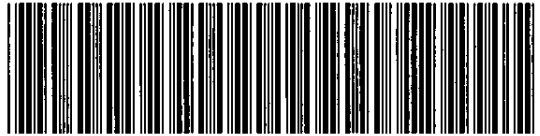

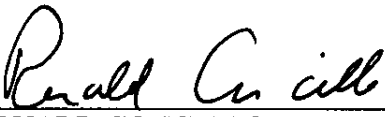
ARTICLE IV-MANAGEMENT
