

ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF MEEKS INTERNATIONAL, LLC



MEEKS INTERNATIONAL, LLC, a Florida limited liability company (the Corapany whose Articles of Organization were originally filed with the Florida Department of State on January 22, 2008 (Florida Division of Corporations Document Number <u>L08000007566)</u>, hereby certifies as follows:

The Company's Articles of Organization are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

"ARTICLE I NAME AND ADDRESS

The name of this limited liability company is MEEKS FINANGIAL SERVICES; LLC (the "Company") and its principal office and mailing address is 15310 Amberly Dr., Suite 250, Tampa, Florida 32647."

- 2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.
- 3. The amendment recited in Section I, above has been duly adopted in accordance with the provisions of \$605.04073, Florida Statutes, the sole member of the Company having executed a written statement, dared December 2, 2014, manifesting his intention that the amendment be adopted.
