**ARTICLES OF ORGANIZATION  
OF  
SOUTHWEST FLORIDA RECYCLING CENTER, L.L.C.**

The undersigned acting as organizer of SOUTHWEST FLORIDA RECYCLING CENTER, L.L.C., under the Florida Limited Liability Company Act, adopts the following Articles of Organization for said limited liability company.

**ARTICLE I  
NAME**




