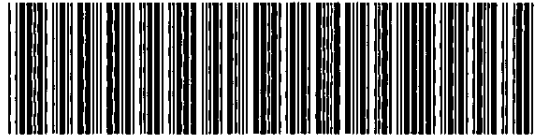




**ARTICLE VI






