The undersigned subscribers to the Articles of Organization, each a natural person competent to contract, hereby associate themselves together to form a limited liability company under the provisions of Chapter 608 of the laws of the State of Florida.

ARTICLE I

#### **ARTICLE XII**

No debt shall be contracted nor liability incurred by or shall be imited liability company except by one or more of its managers.

#### **ARTICLE XIII**

Such transferee shall be entitled to receive only the share of profits or other compensation by way of income and the return of contributions to which that member otherwise would be entitled.
