ARTICLES OF ORGANIZATION OF ADVANCE APPLIANCE ENTERPRISES, L.L.C.

ARTICLE I - Name

The name of this Company is ADVANCE APPLIANCE ENTERPRISES, LLC.

ARTICLE II - Purpose

This Company is organized for the purpose of acquiring and marketing home appliance worldwide and transacting any and all lawful business for which limited liability companies may be formed under Chapter 608 of the Florida Statutes.
