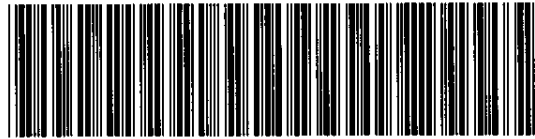

The management of this limited liability company is reserved to the members. The names and addresses of the managing members are as follows:


