**ARTICLE I
NAME & ADDRESS OF PRINCIPAL PLACE OF BUSINESS**

The name of this limited liability company is HURTZ DEISGN GROUP, LLC.

4. If the member is adjudged incompetent or is otherwise unable to manage the LLC, the LLC



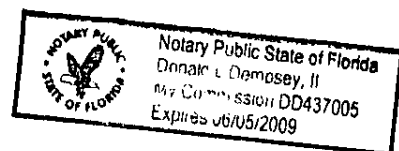
