**ARTICLES OF ORGANIZATION  
OF  
ERM OF ST. AUGUSTINE, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as the same may from time to time be amended (the "Act").

**ARTICLE I - NAME**

The name of this limited liability company (the "Company") is **ERM of St. Augustine, LLC.**

**ARTICLE II - ADDRESS**

The address of the principal office and mailing address of the Company is 5910 Rio Royale Road, St. Augustine, Florida 32080.

**ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of the Company is 1301 Riverplace Boulevard, Suite 1500, Jacksonville, Florida 32207, and the name of its initial registered agent at such address is Donald W. Wallis.

**ARTICLE IV - MANAGEMENT OF THE COMPANY**
