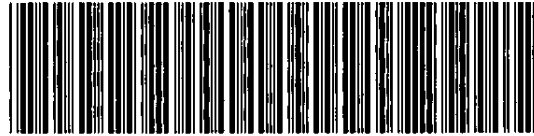

DALINK, LLC


