**ARTICLES OF ORGANIZATION**  
**OF**  
**MIKE DAVIDSON PROPERTIES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be Mike Davidson Properties, LLC (the "Company"). The mailing address of the Company shall be P.O. Box 8670, Jacksonville, Florida 32239 and street address of the principal office of the Company in Florida shall be 9650 Atlantic Blvd., Jacksonville, Florida 32225.

**ARTICLE II**

**PURPOSES AND POWERS**

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. **MANAGER**


