# ARTICLES OF ORGANIZATION OF EVERYTHING FROM USA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

## ARTICLE 1 - NAME

The name of the limited liability company shall be **EVERYTHING FROM USA, LLC** ("Company").

## ARTICLE 2 - ADDRESS

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

## ARTICLE 4 - DURATION

## ARTICLE 5 - PURPOSES AND POWERS

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.


