ARTICLES OF ORGANIZATION OF SON ALSO RISES II, LLC

Under the Florida Limited Liability Company Act

ARTICLE I

The name of this limited liability company is SON ALSO RISES II, LLC (hereinafter "the Company").

ARTICLE II MAILING AND STREET ADDRESS

The mailing and street address of the principal office of the Company is 4770 Biscayne Boulevard, Suite 1200, Miami, FL 33137.

DURATION

The period of duration for the Company is perpetual, except that the death, retirement, resignation, expulsion, bankputch or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the Company, shall dissolve the Company unless a majority in interest of the remaining members consent in writing to the continuation of the business of the Company.

ARTICLE IV REGISTERED AGENT AND OFFICE

The Company's initial registered agent in Florida is Dale Hightower, whose address is 4770 Biscayne Boulevard, Suite 1200, Miami, FL 33137.

ARTICLE V MANAGEMENT

The Company is to be managed by a Manager. The person who will serve as Manager until the first annual meeting of members or until his successor is elected and qualified is:

ARTICLE VI MEMBERS CANNOT BIND THE COMPANY

This Company is managed exclusively by a Manager, and members have no authority to bind it.

ARTICLE VII ADMISSION OF ADDITIONAL MEMBERS

Members of the Company have the right to admit new members only upon the written consent of all existing members, and the existing members shall determine the amount and nature of contributions by new members at the time new members are admitted. An assignee of a member's interest in the Company may become a member only if all existing members consent in writing.

ARTICLE VIII INVOLUNTARY ASSIGNMENT OF MEMBER INTEREST

In the event that a Member's interest in the Company is taken involuntarily, by levy, foreclosure, charging order, execution, or other similar proceeding, the Company shall not dissolve. The assignee of the Member's interest shall be entitled to no more than to receive the profits and losses attributable to said interest and shall not be entitled to participate in any respect in the management or administration of the Company's business or affairs.

ARTICLE IX LIMITATION ON MEMBER WITHDRAWAL

No Member of the Company has the right to withdraw of reduce his capital contribution to the Company except upon the Current consent of all existing members.

ARTICLE X BUSINESS PURPOSE

The purpose of the Company is to engage in any lawful act or activity for which a limited liability company may be organized under the Florida Limited Liability Company Act, as amanded from time to time.

ACCEPTANCE OF DESIGNATION AS REGISTERED AGENT
