ARTICLES OF ORGANIZATION OF R/S CORKSCREW PARTNERS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

<u>ARTICLE I – NAME</u>

The name of the limited liability company shall be R/S CORKSCREW PARTNERS, LLC (the "Company").

ARTICLE II - ADDRESS
