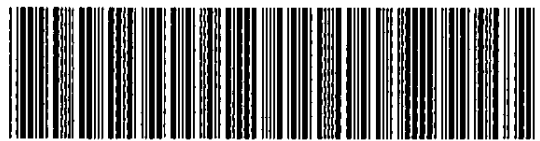



Pursuant to §608.411, Florida Statutes, this amendment is submitted to amend the following:


ARTICLE I of the ARTICLES OF ORGANIZATION is modified to read in its entirety as follows:
