**ARTICLES OF ORGANIZATION

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida. Do set forth the following:

**1. Name.**

The name of the limited liability company is ALL TECH STITCHING, LLC (hereinafter referred to as the "Company").

**2. Period of Duration**

Unless earlier terminated under the Act or any Operating Agreement, the period of duration of the Company shall be perpetual.

**3. Purpose.**

The purpose for which the Company is organized is to engage in the business of clothing manufacture and sale; embroidery application and design, printing and embellishing on fabrics, and any and all other business activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers of a limited liability company organized and existing by virtue of such laws.

**4. Address of Place of Business.**

The mailing address for the Company is 926 Magnolia Avenue, Auburndale, Florida 33823, and the street address of the Company is 926 Magnolia Avenue, Auburndale, Florida 33823. These addresses may be changed from time to time as provided in any Operating Agreement.

**5. Registered Agent.**

The initial registered agent is Marta L. Tilley and the initial registered office is located at 926 Magnolia Avenue, Auburndale, Florida 33823.

**6. Capital Contributions.**

Contributions to the capital of the Company shall be made by the members, in the manner prescribed by any Operating Agreement made and entered into by the members, which may be amended from time to time in accordance with its terms.

**7. Members.**

The Company shall have at least one member and may admit additional members on the proper unanimous written agreement of the then-existing members, or as otherwise provided in any Operating Agreement.

**8. Continuity of Business.**

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all the remaining members of the Company.

**9. Management.**

The overall management and control of the business and affairs of the Company shall be vested in its members, as provided in these Articles of Organization and section 608.407 of the Act, as the same may be from time to time amended. Any and all action by the Company shall require the vote of its members holding a majority interest in the Company.

10. Indemnification.

Except as expressly provided in any Operating Agreement, the Company shall indemnify any member, manager, or former member to the full extent permitted under the Act.


