AMENDMENT AND RESTATEMENT OR THE ARTICLES OF ORGANIZATION

1. He is the current Manager and Secretary of OE RACING LLC, a Florida limited liability company, whose Articles of Organization were filed with the Department of State, State of Florida, on January 29, 2008.
