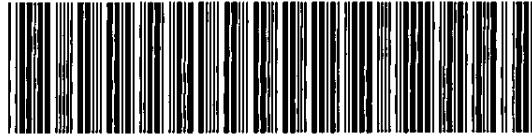

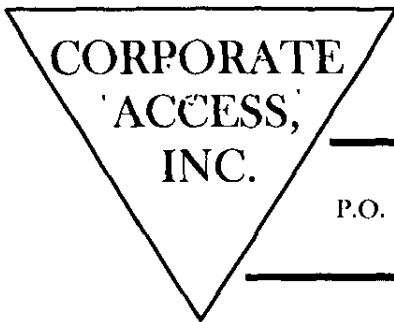

The Company shall be managed by the Members.


**ARTICLE V — LIMITATION ON AGENCY AUTHORITY OF MEMBERS**


