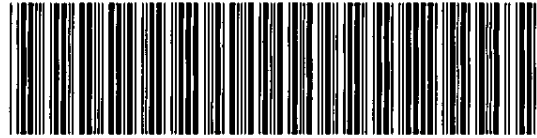

The undersigned hereby certifies that he is the Authorized Representative of a Member who is forming a Professional Limited Liability Company under Chapter 621, Florida Statutes. The following Articles of Organization are hereby adopted.

ARTICLE I.  
NAME

The name of the Professional Limited Liability Company shall be USWF III, P.L.

ARTICLE II.  
DURATION; EFFECTIVE DATE

This Professional Limited Liability Company shall exist perpetually commencing as of January 28, 2008.

ARTICLE III.  
ADDRESS; PRINCIPAL OFFICE

The mailing address of the Professional Limited Liability Company and the street address of the principal office of the Limited Liability Company is 35095 US 19 North, Suite 202, Palm Harbor, Florida 34684.

ARTICLE IV.  
INITIAL REGISTERED OFFICE AND REGISTERED AGENT
