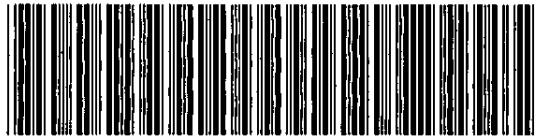

The name of the limited liability company is SMS Holdings Group, LLC.


