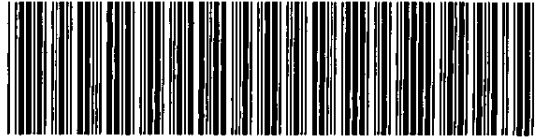



ARTICLES OF ORGANIZATION
OF
ALFIERI AND ASSOCIATES, LLC.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, and/or F.S. Chapter 621, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be **ALFIERI AND ASSOCIATES, LLC.** ("company").

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the company is **5143 NW 42 Terrace, Coconut Creek, FL 33073**. This address may be changed from time to time as provided in the Operating Agreement.

ARTICLE III – DURATION

ARTICLE VI – CAPITAL CONTRIBUTIONS




