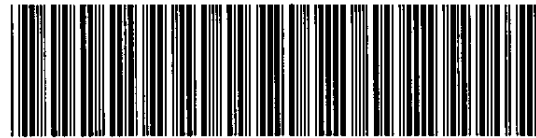




ARTICLE V -- GOVERNED BY OPERATING AGREEMENT

These Articles of Organization shall be effective upon the date of filing.



