The undersigned, ROBERT T. KAMM, a natural person competent to contract and an authorized representative of a member of RESORT CONNECTION REALTY, LLC hereby presents these Articles of Organization as the Articles of Organization of RESORT CONNECTION REALTY, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME
