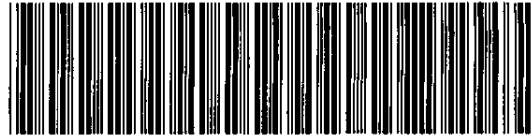

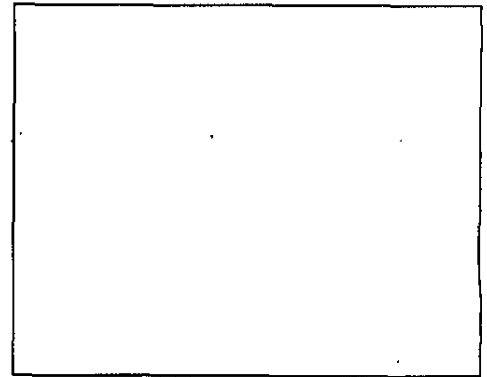

ARTICLE IV - REGISTERED OFFICE AND AGENT

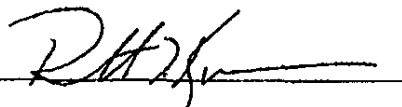

These Articles of Organization or any amendment thereto may be amended in accordance with the Florida Limited Liability Company Act.

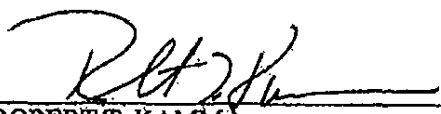
